I. STYLE SHEET

Title (capital letters, bold type, centred, size 14)

Scientific degree and author(s)' name (bold type – only for the name, aligned right, size 12 - e.g. PhD Student Sandra Marked)

Affiliation – The institution where the PhD student is enrolled (align right, size 12)

Scientific degree and name of the PhD scientific advisor (bold – only for the name, aligned right, size 12 - e.g. Prof. Dr. Sandra Marked)

(blank space, followed by the content of the paper)

Abstract and key words: Times New Roman font type, italic, justify, size 12.

The **text** shall be typed on A4 size, margins: left 3 cm, others 2.5 cm, Times New Roman font type, justify, size 12.

Please do not insert page numbers.

No line(s) feed between paragraphs, the text shall be continuous.

Headings (chapter titles) shall be written with a blank line preceding and following them.

Within chapters, subheadings shall be italicized with a blank line preceding and following them.

References in the text shall be numbered automatically, as footnotes.

A **list of references (bibliography)** shall be inserted at the end of the paper. The recommended form of the list of references at the end of the paper: 1. Lippman, M: *Contemporary Criminal Law*, London: Sage Publications, 2007.

The paper shall be written in English or Romanian and shall be accompanied by an abstract in both English and Romanian (should you not be able to have your abstract translated in Romanian, please inform the organizers about this matter upon registration). If submitting a paper in English, please ensure an adequate academic linguistic level of the text – proof-reading by a native English speaker is recommended. If the paper is written in English and it does not meet the aforementioned standards, it shall not be published in the conference volume.

II. CONFERENCE PROCEEDINGS AND PUBLICATION OF THE CONFERENCE VOLUME

Conference Sections: Public Law and Private Law

The paper presentations shall take place in the Conference Halls of the Faculty of Law (video projectors are available).

In each section, the time allotted to the oral presentations shall be 15 minutes.

The submitted papers (no longer than 15 pages, A4 format) will be published in the conference volume, provided that the proof of payment of the participation fee, the abstract and the paper shall be received no later than May 3rd 2020.
